Bregenz, July 5, 2010. Pursuant to sec. 92 para. 2 Austrian Stock Exchange Act (*Börsegesetz*, "BörseG"), Wolford AG announces it was informed by First Rock Trustees Limited, Waterport, Gibraltar, pursuant to sec. 91 BörseG as follows:

„We, First Rock Trustees Limited, Suite 5, Watergardens 4, Waterport, Gibraltar, as fiduciary and trustee, thus as proxy, of Bartel 2006 Trust, Suite 5, Watergardens 4, Waterport, Gibraltar, and Bartel Family Trust, Suite 5, Watergardens 4, Waterport, Gibraltar, hereby make the following announcement:

On June 30, 2010, Bartel 2006 Trust, Suite 5, Watergardens 4, Waterport, Gibraltar, purchased shares in Wolford AG, an Austrian stock corporation with its registered seat in Bregenz and its address at A-6901 Bregenz, Wolfordstraße 1, registered with the company register of the state court Feldkirch unter FN 68605s („Wolford“), and hereby acquired more than 5 % of the voting rights.

Bartel 2006 Trust and Bartel Family Trust are Trusts under the laws of Gibraltar; they are the direct shareholders.

(iv) *Names of shareholder and of person entitled to exercise voting rights on behalf of the shareholder*

Bartel 2006 Trust and Bartel Family Trust, each with its address at Suite 5, Watergardens 4, Waterport, Gibraltar, are the direct shareholders. The voting rights of Bartel 2006 Trust and Bartel Family Trust are exercised by First Rock Trustees Limited, Suite 5 Watergardens 4, Waterport, Gibraltar, as fiduciary and trustee, thus as proxy, of Bartel 2006 Trust and Bartel Family Trust. Because of the discretionary nature of the trusts, First Rock Trustees Limited as *trustee* has the material decision making authority with respect to the exercise of the voting rights. The voting rights of Bartel 2006 Trust and Bartel Family Trust of 400.000 votes or 8 % of the voting rights in total are therefore accumulated (and attributed to each of the trusts).“
